## Minnesota Forest Resources Partnership 2015 Annual Report Submitted by Chair Dick Moore

## 1. Significant Activities

Highlights:

- \*The MFRP concluded its partnership with the University of Minnesota in the development of the Great Lakes Silviculture Prescription Library. The project created an online platform where forest managers from Michigan, Minnesota, Ontario, and Wisconsin can exchange silviculture prescriptions. The project is ongoing, showcasing innovation and fostering adoption of practices that increase forest resilience and productivity.
- \* The MFRP has committed to keeping the recommendations of the 2014 Study of the Competitiveness of Minnesota's Primary Forest Products Industry in focus in 2016 and beyond.
- \* The MFRP welcomed a new board member: The Minnesota Deer Hunters Association.
- a) MFRP completed the year in a particularly financially sound position, with a balance of over \$13,000 at year's end 2015.
- b) MFRP kept the study of the *Competitiveness of Minnesota's Forest Products Industry* 'off the shelf' by committing its April meeting to a first quarter report of implementation of the recommendations..
- c) A one-day retreat of the MFRP Executive Committee was held during which the MFRP mission statement was updated and the MFRP was committed to exploring the updating of the GEIS/addressing concerns of harvest levels.
- d) A new member was added to the MFRP Board of Directors: the Minnesota Deer Hunters Association.
- e) A grant request to the Weyerhaeuser Forest Foundation was prepared for expanding on the Workforce Development recommendation of the Competitiveness Study. The grant was not funded, but work began on implementing the recommendation with the cooperation of the Minnesota Logger Education Program and UPM Blandin.
- f) Nomination of the MFRP to the NE Loggers Association Forestry Service Award was made but not successful. The NELA encourage submission of a nomination of award in 2016.
- g) MFRP Executive Director met with a small group listening session with DNR Commissioner Tom Landwehr, upon invitation of the Commissioner, to discuss current forestry concerns in the state.
- h) The MFRP was able to freeze assessments for 2016 at the 2015 level because of prudent budgeting and conservative expenditures during 2015.

**Wayne Brandt,** Minnesota Forest Industries, provided a review of the 2015 legislative session, noting that it had convened January 4 and adjourned May 18 with still unfinished business.

**Craig Engwall,** Executive Director of the Minnesota Deer Hunters Association, informed the MFRP board and its guests of the MDHA's membership (20,000 members and 62 chapters), and project activities, noting especially the Pineland Sands issue pertaining to purchase of Potlatch lands. These lands have some of the highest deer densities in the state.

**Amber Ellering,** Forest Analyst with the Minnesota Department of Natural Resources, provided an update on the northern long-eared bat and its listing as 'threatened' through the Endangered Species Act. She discussed the 4D ruling that allows for forest management exemptions. She noted that the ruling was not comprehensive for all activities but that it was a 'good start.'

**Alan Ek,** University of Minnesota, discussed findings of the LCCMR Rapid Forest Inventory Project, summarizing that it focused on how to make forest inventory more efficient.

- \* Explore the updating of the Generic Environmental Impact Statement with the intent to address issues of harvest levels and to contribute toward expansion of forest industry in Minnesota.
- Develop projects/plans in cooperation with Partners to carry forward the Workforce Development recommendations of the 2014 Competitiveness Study.
